#### (1) OPENING REMARKS:

The meeting commenced at 6:05 pm with Sergio Carvana welcoming everyone. Cathy Dubee and Jan Johnston sent their regrets prior to the meeting.

# (2) Canaport LNG 10 Year Anniversary & Community Report Presentation

Kate Shannon provided an overview of Canaport LNG's 10 month long celebrations in light of their 10 year anniversary. Details can be found in the presentation attached.

Following the presentation, the Committee thanked and acknowledged Canaport LNG for their contributions to the community.

Gordon Dalzell suggested Canaport LNG attempt to have their community contributions recognized in the *LNG World* magazine, and have them feature a story.

One of the committee members inquired on the recent news of TransCanada's potential plan to send gas via pipeline from Alberta to the east coast.

Sergio provided clarity on the development, in that there were talks of re-purposing an existing line from Alberta to Ontario for the purpose of shipping natural gas, then connect the existing pipe through to tie into the Maritime North East pipeline. This would allow a gas supply to the Atlantic, whereby the natural gas resources on Sables Island are being depleted.

Q1. (Gordon Dalzell): What kind of impact would that have on the Terminal? A1. (Sergio Carvana): The Terminal would potentially be at a disadvantage, although it may be a good thing for New Brunswick with our current source of natural gas being depleted.

# (4) UPDATES - Canaport LNG Update

#### **Canaport LNG Site Update**

The following site highlights were given by Sergio Carvana:

- Canaport LNG is having a better February this year than last, and it looks like it may be a better March. The less predictable the weather is, the more profitable the Terminal is:
- Regular maintenance is occurring, or is scheduled at the Terminal;
- No incidents occurred at the Terminal since the last meeting;
- Canaport LNG's bi-annual report was submitted to the Department of the Environment with no issues;
- The Greenhouse Gas Management Plan update, which is a requirement that stems from the Approval to Operate, was submitted to the Department of the Environment; and
- Greenhouse gas emissions in 2018 is less than 10,000 tonnes; therefore, reporting or paying tax on carbon is not required by the Terminal at this time.

David Thompson stressed the importance of community liaison committees with industries to keep communications open, and that these types of groups are advantageous to communities.

Gordon Dalzell commended Canaport LNG on their communications report in that it was very easy to read, informative, and nice to see the different initiatives.

Gordon Dalzell made note of the NB Air Quality 2016 monitoring report that is now available online through the Department of the Environment for anyone who may be interested.
